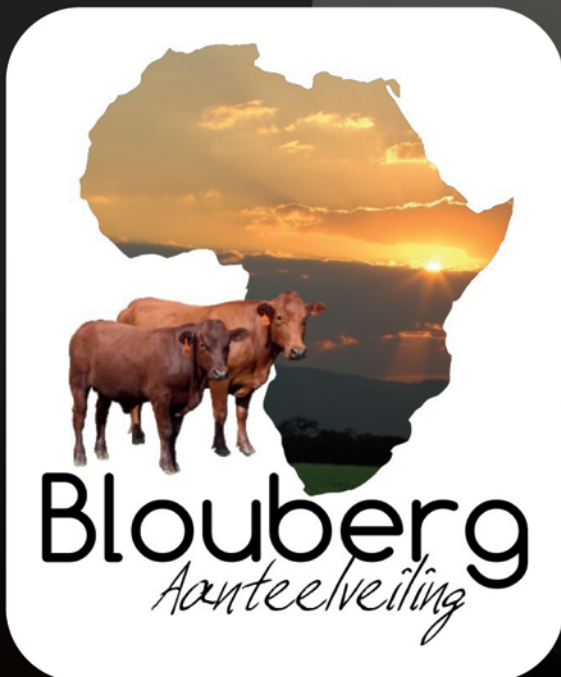

01 Augustus 1930 – 21 September 2022

Willie Roux was dalk 'n man van min woorde maar glad met die bek op die vendusie podium, lekker-lag-man, rots-man, statige man en 'n lojale man wat nooit nagelaat het om tyd te maak vir elke koper en verkoper nie.

In 1964 het hy as bemarker by Vleissentraal Malelane begin waarna hy in 1970 verplaas is na Louis Trichardt om veilings in die Bosveld te behartig. In 1974 was Suid-Afrika se eerste wildveiling deur hom aangebied in Hoedspruit, wat vir hom een van sy grootste mylpale was.

In 1994 het hy saam met Anton Bothma, Hendrik Knox en Robbie Emmerich Blouberg Aantelweiling begin en was 'n trotse bemarker en afslaer in ons omgewing gewees. Hy het sy laaste veiling, hier op Vivo, op ouderdom 83 jaar aangebied.

Veilings groot of klein, hy het altyd dieselfde moeite gedoen en die ekstra myl gestap. Hy het 'n persoonlike band met elke koper en verkoper gehad en so ook altyd almal op dieselfde manier hanteer, professioneel en met respek. Koper of verkoper kon op hom staatmaak en hom vertrou. Hy het seker gemaak hy kry jou telefoon nommer sodat jy op sy bel lys kom, hy het ook seker gemaak almal in die omgewing weet as daar 'n Blouberg aantelweiling aangebied word en presies hoeveel van watse diere staan in watter kraal. Hy was baie noukeurig op sy voorbereiding, iets wat hom laat uitstaan het bo ander.

Vandag is Blouberg Aantelweiling welbekend in Limpopo en hy was baie trots om deel te wees van hierdie veilingsgroep, sy mense en kollegas.

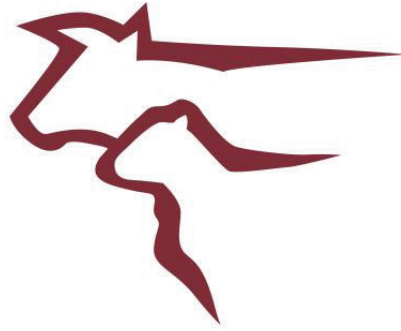

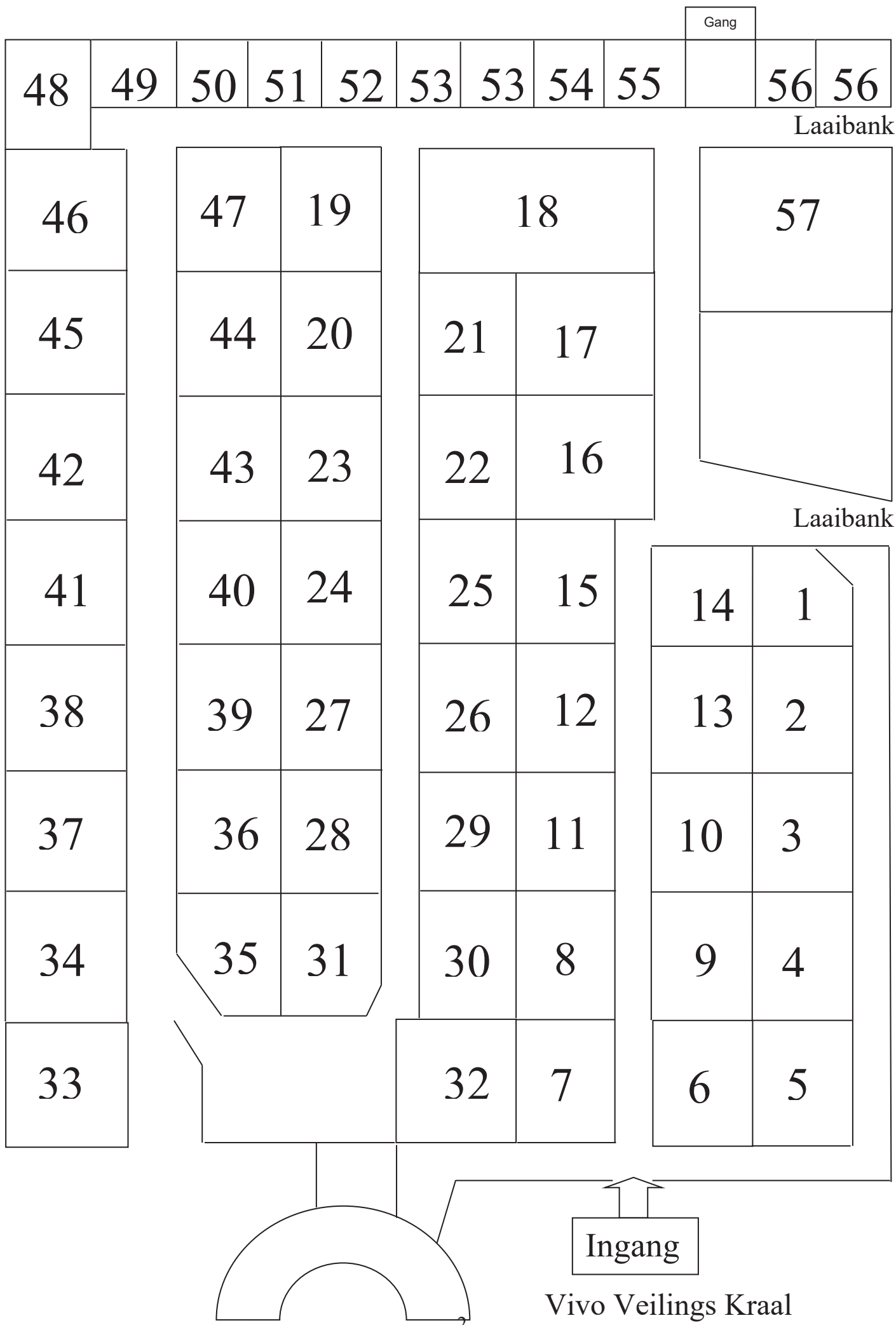

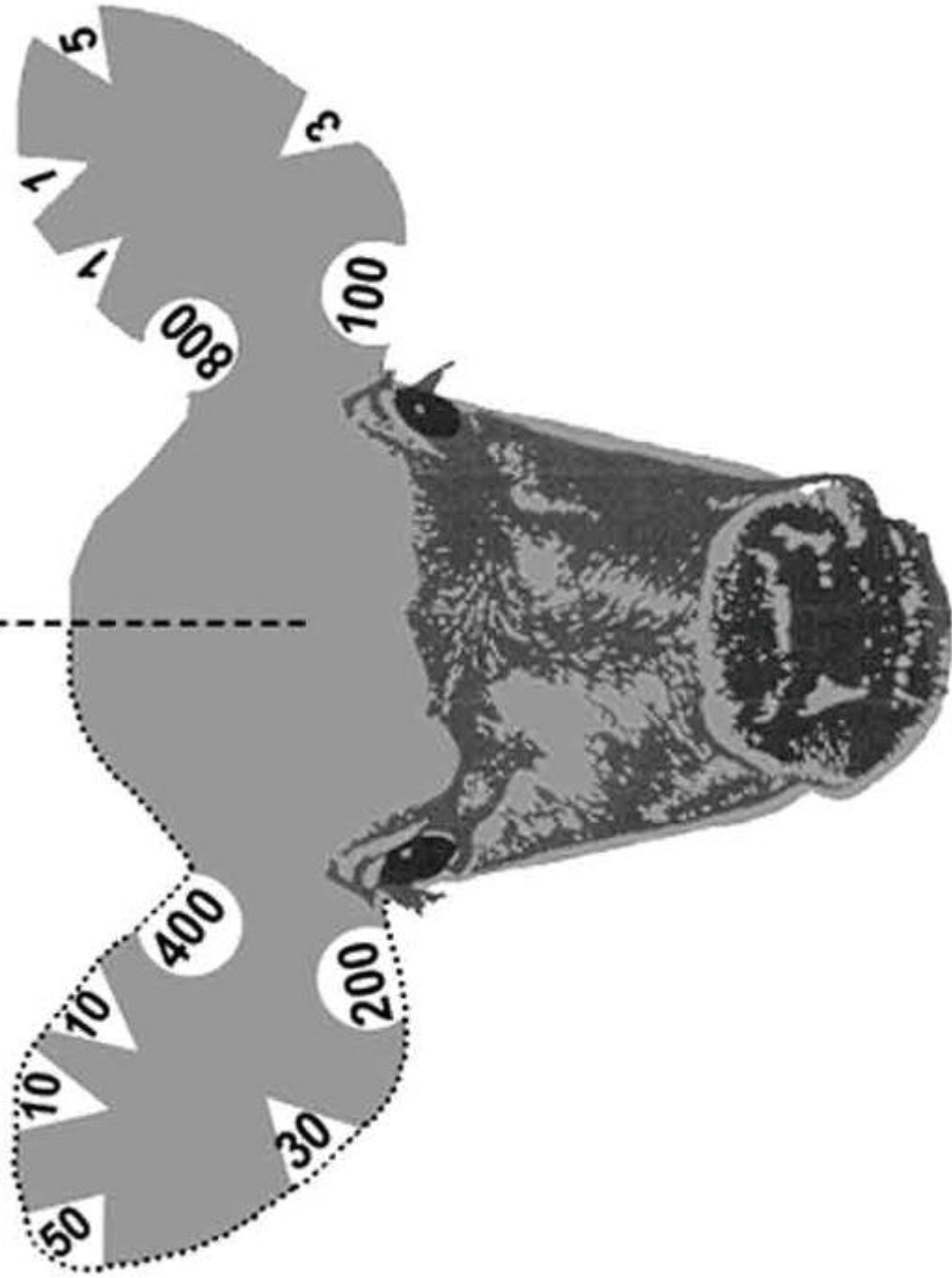

RULES OF AUCTION in respect of the sale,

1. The Sale by auction is subject to a reserve price, unless specifically stated to the contrary by the auctioneer.
2. The seller (owner) and/or his/her representative and/or his/her agent and/or the auctioneer may not bid on any of the seller's / owner's goods sold by auction unless it has been specifically advertised or announced from the podium that the auctioneer or seller (owner) or the respective agents or representatives reserve the right to do so.
3. This *Rules Of Auction* comply with Section 45 of the Act and the Regulations of the Act and Section 45(2) of the Consumer Protection Act, Act 68 of 2008 ("the Act") read as follows:
"Auctions:
45(2) When goods are put up for sale by auction in lots, each lot is, unless there is evidence to the contrary, regarded to be the subject of a separate transaction.
4. The auctioneer will during the auction announce the reason for the auction unless the reason is the normal and voluntary disposal by the owner.
5. The auction will commence at the published time and will not be delayed to allow any specific person or more persons to take part in the auction.
6. All goods and livestock (hereinafter referred to as the "assets") are sold by the Auctioneer as agent on behalf of the Seller, who hereby authorizes the Auctioneer to collect the purchase price from the Buyer and the seller do hereby cedes to the Auctioneer all the seller's rights, title and interest in and to its claim for payment of the purchase price against the purchaser which session the Auctioneer do hereby accepts.

20. 26. 28. 37.
